CALIFORNIA GOVERNMENT CODE SECTION 1090: INTEREST DISCLOSURE

Pursuant to California Government Code Section 1091.5(a)(9), a city officer or employee does not have a financial interest in a city contract if these conditions are satisfied: (i) his or her interest is that of a person receiving a salary, per diem or reimbursement for expenses from a government entity; (ii) the contract does not directly involve the department of the government entity that employs him or her; and (iii) the interest is disclosed to his or her body or board at the time the contract is considered and is noted in its official record. In accordance with this statute, the individual Board members identified below request that the Board note in its official records that they receive a salary, per diem or reimbursement for expenses from the City of San Diego: Franklin Lamberth, Steve Meyer, John Thomson, Jo Anne SawyerKnoll and Mark Sullivan. John Thomson is also a Board member of San Diego Fire Fighters Local 145 and a DROP participant. Joe Flynn notes he is a retired City employee and receives a retirement allowance from SDCERS. Mark Sullivan is also a Board member of the Police Officers Association.

I. NON-AGENDA PUBLIC COMMENT

This portion of the agenda is for members of the public to address the Retirement Board on any subject within the Board's jurisdiction that is not on today's agenda. To address the Board during Non-Agenda Public Comment, you must complete a Request to Speak form and submit it to the Board Secretary before the meeting begins. To address the Board on a subject that is on today's agenda, you must submit a Request to Speak form before the item is called. These forms are located in the back of the Board Room. The chairperson will call your name to address the Board during Non-Agenda Public Comment or when your item is to be heard. Non-agenda Public Comment is limited to 3 minutes per speaker and 15 minutes per topic. Public testimony on an item on the agenda is limited to 3 minutes per speaker and 15 minutes per side.

II. APPROVAL OF CONSENT AGENDA ITEMS A-F

Retirement benefits paid by SDCERS must comply with the Plan and the limits set forth in Internal Revenue Code Section 415(b). Under the Plan, any benefits that exceed these limits must be paid from the Preservation of Benefit Plan (POB), which is designed to be a Qualified Excess Benefit Arrangement. Excess benefits cannot be paid from the SDCERS trust fund. SDCERS has submitted a Voluntary Correction Program (VCP) filing addressing past excess benefits paid and committing to implement ongoing testing procedures beginning in January 2007. SDCERS is also filing a private letter ruling request with the IRS to approve a new POB structure. These procedures and the new structure provide that excess benefits are paid from the POB. Accordingly, the Board's approval of the retirement benefits on this agenda will not result in the violation of Code Section 415(b).
