Jim, Mr. Tom Crabbe (619) 997-4359 called asking to speak to you regarding concerns that he and his neighbors have.

Emergency work was done last night by the Water Department. The crew did a great job. **However, he and his neighbors are very concerned because something is going on in the area.** The street that was patched last March has separated and the street appears to have dropped 3 inches. He believes the City just plans to repatch the street. They feel the ground may be shifting which may have caused the break last night. There was major damage in the past on Desert View Drive (to 4 homes) which is below their street. They feel that the City should send out a geologist to see if something is happenings in the area, before any major damage occurs.

He would like someone to call him back regarding their concerns.

Jim/Alex,

Stan Medina and I visited the site yesterday. In addition, we reviewed our records since January 2004 to determine the history in the area from a water perspective.

A review of the records, shows that the blown service (initially reported as a main break) on July 18th is the only water related activity in the immediate area (+/- 1/4 mile) since January 2004. The blown service was approximately 50 feet away from the tear in the street. In addition, Mr. Crab reported that the tear appeared in March 2007. Based on this, our blown service could not have caused the tear in the street.

The tear in the street is located above the sewer main (see attachment). I would recommend requesting MWWD to televise their sewer main to see if they have a problem with it. If they do, they should proceed to repair the street. If not, then the street repair should go to Streets. Jim

All:

The following is a summary of today's observations from Jim Fisher, Water Ops Division Deputy Director, who personally visited the Soledad Mt Rd site this morning:

- A water leak reported on Friday was the result of a defective repair saddle. It appears that the adhesive used to attached the gasket to the stainless steel saddle failed and allowed water to leak out. - The actual amount of water coming from the previous repair/patch was minimal, so the leak was held until today for repairs.
- The cracks in the street do not appear to have changed since Operations Division managers visited the site a couple weeks ago.
- The report of "a lot of water" was the result of the main draining activity associate with the leak repairs and the excavated hole being pumped out. As mentioned before there was minimal leakage coming from the failed saddle itself.
- Our understanding was that SDG&E was on site to shutdown a gas service to a single residence who had a leak and that it was in no way related to the leaking water service.
- Johnny Mitchell, Acting Construction Manager spoke to Mr. Crab, who showed Johnny what he thought was additional ground subsidence and a crack on the house at this address (see attached pictures). Neither the subsidence or crack appear to be related to the blown service in mid July, nor the leak on Friday.

In conclusion, it does not appear that anything has changed in the area since the last time we were out there in mid July.

Staff will follow-up on the on-going analysis of the area in an effort to eliminate potential causes of street cracking. Staff will follow-up with MWWD to see what they have found in the televising of the sewer main, then with Field Engineering on boring the street to see if there is any undermining occurring.

Dear Mr. Hawk,

I know that you have been concerned about what is happening on our street (Soledad Mountain Rd. in La Jolla). We are very concerned as well, because we are next door to the garage that appears to have serious structural damage. We have noticed some very recent changes and problems which I will list. I will also attach pictures to illustrate our concerns.

Cracks on our outside stucco wall on the same side as the neighbor's damaged garage.

Cracks in the cement pathway next to that wall.

A cracked planter on that same side.

Movement of bricks on a brick pathway on that same side as well as in front of our house.

Separation of the front sidewalk from our tiled entry and separation of the sidewalk from our driveway.

Separation of our garage wall from the driveway.

Separation of a tiled walkway from the front wall of the house.

There are other cracks and such, and all this has been recent. If you visit our property, you will see that we maintain our house and improve it regularly, which has made us and our regular handyman very aware of these new developments. On August 3, before going out of town, I called in to let the city know that there was a problem with water coming up and puddling on our street. Next day I called again to ask why no one had come because the water was oozing out again and causing another puddle.

We know SDG&E has been working on gas leaks, and we have had a dreadful off-and-on sewer smell for a while. We fear all the water that has been forcing its way up from underground might be destabilizing the ground.

We thank you in advance for your attention to this serious matter.
